VISA SPONSORSHIP GUIDANCE

The University of Kansas Medical Center (KUMC) offers J-1 visa sponsorship under the Alien Physician category for any matched and qualifying international resident and fellow. The J-1 visa for physicians is administered by the ECFMG (Educational Commission for Foreign Medical Graduates). Under eligible circumstances, KUMC can offer H-1B visa sponsorship for residents and fellows. H-1B visa sponsorship is reviewed on a case-by-case basis and dependent upon a program's ability to sponsor. Prospective residents and fellows would need to confirm with their respective programs if H-1B sponsorship is available.

PROS	<ul style="list-style-type: none"> • Quick processing <ul style="list-style-type: none"> ○ i.e. From Match Day, DS-2019 issued by May, J-1 visa stamp obtained end of May or early June • 7-year duration • USMLE Step 3 not required for initial sponsorship • Straightforward transfer process from residency program to fellowship program 	<ul style="list-style-type: none"> • Flexibility to seek work sponsorship after residency/fellowship training • Appropriate visa option for applicants initiating or in the process of applying for U.S. permanent residency status • USCIS Premium Processing Service available (guarantees a decision on the H-1B case within 15 calendar days) • Can be granted for an initial period of 3 years
CONS	<ul style="list-style-type: none"> • Potential delays in obtaining a Statement of Need (SoN) letter • Administrative processing or limited visa appointments at U.S. consulates could result in delays • Specific health insurance requirements • 2-year home stay requirement or 212e applies automatically affecting H-1B and permanent residency (family/employment based) eligibility 	<ul style="list-style-type: none"> • For consular processed H-1Bs, delays could occur due to limited visa appointment availability or administrative processing at U.S. consulates • 6-year maximum duration • Delays and/policy changes with the USCIS that could impact cases
